RE: ATRIP Contract Closeouts

As part of the Acceptance for Maintenance process outlined in Item 105.15(c)3.. a "record check" of materials and workmanship is performed by the Bureau of Materials & Tests (M&T). This review is initiated by a form letter from the Construction Bureau to M&T and includes reviewing the BMT-38s and/or IAS&T records. Once the "record check" is completed, M&T inputs certain dates into CPMS and generates a Certification of Materials & Tests (also known as the COM). Final Acceptance, as outlined in Item 105.15(c)6., and the Final Estimate cannot be processed until the COM letter is completed and submitted.

For ATRIP contracts, the Division/Region is responsible for all materials issues as prescribed in the Memorandum of Understanding with Federal Highway Administration. Therefore, the Division/Region must perform this review and submit the COM letter to the applicable parties. Based on questions this office has been receiving, there appears to be some confusion on how the process should work.

Henceforth, the Construction Bureau will modify its Acceptance for Maintenance letter to the Contractor so that the respective Division/Region will be responsible for performing the "record check". An example of this letter is attached.

Once the Division/Region completes its review, it will prepare a COM like the attached example and submit it to the distribution list indicated on the letter. Once M&T receives the COM, it will input the date of the Materials Certification Date and FHWA Acceptance Date into CPMS. At this point, the Construction Bureau is ready to process the Final Acceptance and Final Estimate once the Division/Region and the Contractor completes the final quantity and final estimate documentation process outlined in Article 109.12.

Should this Department find upon completion of the "Record Check" that any of the materials or workmanship fails to meet the requirements of the plans and specifications, you, as contractor, will be required to make such changes as necessary to correct the deficiencies without expense to this Department.

You are hereby requested to furnish proof that due notice has been given to any and all persons desiring to file claim against the Contractor. This notice should be in the form of an advertisement, and should be inserted for four consecutive weeks in some newspaper of general circulation, published within the County or Counties, in which the work was done. Mail three copies of this notice, attached to publisher's affidavit that it appeared in his newspaper, and the dates on which it appeared to our Division Engineer, Mrs. L. Dee Rowe, Alabama Department of Transportation, P.O. Box 70070, Tuscaloosa, AL 35407. For your information a typical advertisement is attached.

Should the contractor be required to correct any deficiencies after the "Record Check" has been made, the contractor must re-advertise at his expense.

Final acceptance will not be made until after the "Record Check" has been approved by the Fifth Division.
