Reference: MPO Safety Performance Measures (PM1)

As stated in Local Transportation Bureau Memorandum 2019-3, this notice serves as a reminder of the upcoming deadline for safety performance measures. A resolution is due to this office, either confirming ALDOT's PM1 targets or establishing their own PM1 targets, by February 27th, 2019. More information about PM1 targets is included in the attached memorandum.

It is the MPO's decision as to whether to adopt the State's performance measures or develop their own. If the MPO chooses to adopt the State's measures, a resolution should be developed containing the attached information. If the MPO desires to develop their own performance measures, the State has developed a portal to house safety data for each MPO. The Safety Portal is located at <https://safety.aladata.com/>.

Reference: Safety Performance Measures Targets for 2019

Under MAP-21 and the FAST Act, the Alabama Department of Transportation (ALDOT) in conjunction with the Alabama Department of Economic and Community Affairs (ADECA) must establish statewide targets for the following categories: number of fatalities, rate of fatalities, number of serious injuries, rate of serious injuries, and the number of non-motorized fatalities and serious injuries.

Each Metropolitan Planning Organization (MPO) reserves the option of adopting the statewide targets as established by the ALDOT, or the MPO may elect to establish its own targets for the year.

ALDOT established the previously referenced Safety Performance Targets for 2019 as shown below.

Number of Serious Injuries	8,469
Number of Fatalities	932
Rate of Fatalities (per MVMT)	12.08
Rate of Serious Injuries (per MVMT)	1.33
Number of Non-Motorized Fatalities and Serious Injuries	394
